In 2023, The GNC completed a variety of accomplishments such as revising CAPIC By-laws, conducting a thorough review of the policies, charters, and mandates of all committees, exploring strategies for acknowledging the contributions of CAPIC volunteers, and recommending the removal or substitution of volunteers due to inactivity, policy violations or role changes. positions in line with GNC eligibility criteria, coordinated on workplans and assignment of responsibilities to comply with quarterly objectives, among others.

Anticipated policy revisions will provide CAPIC volunteers with opportunities to contribute under the updated guidelines and bylaws. ## MEMBERSHIP SERVICES COMMITTEE

2023 was a pivotal and challenging year for CAPIC Membership. At the beginning of 2023, our membership stood at 4,292, including 4,148 registered members. Throughout the year, we received and finalized 540 membership applications, culminating in a total membership of 4,391 by year's end. Of this total, 4,224 were registered members, representing 37% of all Regulated Canadian Citizenship and Immigration Consultants (as of June 2022).

2023 was a busy year for the E and T committee, meeting five times in the governance year, with the mandate of shepherding the education and training program for the organization. A highly engaged set of volunteers, the Committee provided a framework of collaboration with supportive oversight and incredible brainstorming. In 2023 the Committee sought to ensure that CPD learning was focused on specific target audiences - for newer consultants - "What now" "Essential Skills" and "Getting Down to Business" learning series were created to promote learning and growth, in both the immigration domain and business support. 2023 also saw the evolution of the Summit Series, elevated sessions for those more seasoned in the profession. Topics ranged from Small Town immigration, Is Canada still the dream destination, and ATIPS, Chinook and Reconsiderations. The Committee saw the need for a balanced Seminar Bundle program that could cater to the various needs of CAPIC members, and 2023 offerings included 60 CPD hours and 26 seminar events, most offered in English, with up to 16 hours offered in French.

The Committee recognized the changing face of the profession and the often-preferred access for remote learning but also understood the perspective of having in person sessions where learning and networking thrive. In person



events were held in Vancouver, Edmonton, Calgary, Montreal, Toronto, and Halifax where CAPIC members mixed, mingled, and learned together. It was truly coast to coast!

More than 50 speakers were on the CAPIC podium as part of regular CPD programming. Consultants, lawyers, and industry speakers shared their knowledge and expertise in a variety of areas. There were many new names in 2023, with the Committee empowering operational staff to continue to seek a variety of perspectives and experience. The committee heartily thanks CAPIC's regular roster of presenters and welcomes those who were new to the podium.

With so many events it's difficult to point to some because all offered something valuable. The year began with CAPIC and CICC offering a joint session – Let's talk Regulator Role and a Session on Ethics. This session was also later presented to our French members live in person! CBSA, IRCC, ESDC and MIFI participated in several events, nearly all in person and provided insight. Nova Scotia PNP attended our "CAPIC Kitchen Party" in Halifax where CAPIC also welcomed new speakers to the podium. Other popular sessions included LMIA- A Practical Seminar, Professionalism and the Code, Setting Fees, Explore the World of R205, and Policy Updates!

Prep courses were part of the docket in 2023, with the IRB Prep course being offered 3 times, with fantastic feedback from those participating. Next gen soon to be RCICs opted for the EPE Prep Course, offered in a long 40-hour format or brain blaster 12-hour prep.

The Committee understands that learning and growth is not necessarily all CPD, and that personal connection and networking is just as important. 2023 included 6 CAPIC Cafes - closed online networking sessions and 6 in person lunch and learns in a variety of regions – sessions geared to connect, share, learn and grow - safe spaces to ask questions. These sessions are interwoven into regular CPD programming so that CAPIC members have opportunities beyond to connect.

The Committee saw the need for a balanced Seminar Bundle program that could cater to the various needs of CAPIC members, and 2023 offerings included 60 CPD SEMINAR BUNDLE hours and 26 seminar events, most offered in English, with up to 16 hours offered in French.

Exclusive of the NCIC, CAPIC offered 68 events and nearly 80 CPD hours from the Seminar Bundle, workshops, various learning series, in person sessions, and so much more. The Committee takes their mandate seriously and believes in a strong education and training program, that will provide learning, information, and support to CAPIC members. Their insight and diligence persisted throughout the year as the Committee work plan was reviewed and tasks undertaken. A sincere thank you to Committee members, volunteers, and operational staff for their hard work throughout the year, and striving to create a positive, inspiring, informative learning environment.

With the support of CAPIC members and the leadership of its governing group, CAPIC Connect has evolved into an exceptional membership platform over the last

decade. It continues to serve as a valuable space for learning, networking and professional development.

As platform features are continuously developing, CAPIC Connect retains its user-friendly interface, while offering members enhanced intuitiveness and enjoyment.

#### Current Technologies:

CAPIC implemented cutting-edge upgrades to its technological framework that continues to be put into effect. Among these include the adoption of Microsoft's cross-platform framework, enabling seamless transitions between multiple operating systems such as Windows, Linux and MacOS. This advancement played a crucial role in CAPIC's ongoing efforts to establish a robust technology infrastructure for consultants, ensuring smooth connectivity across all applications on all types of devices such as mobile, desktop, web, cloud, internet of things (IoT), machine learning, and artificial intelligence-based apps.

#### Enhanced User Interface:

The front-end screens of the new CRM that were revamped in 2022 also continue to facilitate the development of fully responsive, mobile-first websites that cater to a wider range of device types.

#### Security Measures:

To further enhance security, usernames and passwords continue to be safeguarded using Microsoft's inbuilt identity system, which includes one way password hashing, password validations, secure user storage and two-factor authentication. IMMeFile is the most affordable and complete client management application tool in the industry. It allows you to automate and manage the minutiae of your business, from cases and applications to client correspondence. IMMeFile subscription is free with CAPIC

Membership. IMMeFile features: file management (contacts & applicants, IRCC forms & documents, notes, accounts, client intake forms); automatic emails; automatic file updates; automatic payment plans; tasks and reminders; assessments/ prospect management; time tracking; customizable interface to reflect your brand; security exceeding industry's standards, IMMeFile mail server.

Upcoming features includes retainer/documents automation; client status adjustability; convert assessment to client option; client status analytics; time entries export.



IMMeJobs was initiated in 2023 to connect our RCIC members to potential employers who need someone specializing in immigration and citizenship on board. It is a project free of charge to both participating employers and CAPIC



members.

™ In 2023, a significant development was the launch of IMMeLegal, a publication designed to discussing current Immigration Law topics to inform RCICs on legal matters. IMMeLegal offers ATIP exclusively done by CAPIC to its members,

review of recent legal rulings, insider tips and information, as well as in-depth articles on relevant immigration law topics.



Manother important milestone in 2023 was the launch of IMMeSupport, an education blast geared to assist immigration consulting students and those who have just begun their immigration consulting career. IMMeSupport encompasses

input from students, new graduates and seasoned practitioners to guide new RCICs.



Our member-driven MyConsultant.ca (MC) project offers CAPIC members access to global markets through online promotion. Introduced in March 2018, the MC platform is designed to connect CAPIC members with citizenship and immigration seekers globally. The platform saw over 457,662 visits and over 254, 29 visitors in 2023. It serves as a promotional tool to drive traffic to participating members' MC profiles. It is also a practical testing tool for non-participating members, showing them the list of services, descriptions, locations, etc. that may help them veer in a better direction of their practices.

MC's level-based services offer the flexibility that immigration and citizenship consultants need to expand their practices globally. Three levels of subscription and the option to sign up for a month or a year allows participating members to testrun the platform and change their subscription at any time. Level 1 subscription is FREE, so we highly recommend our members activating their MC profile. Though Level 2 and 3 are paid subscriptions, each option comes with a free period of up to 3 months. The annual fee of \$400.00 applies to the top-level 3 members, including maximum exposure in a digital web banner all on its own at the top of the homepage of MC, in addition to the 3 months of free services - the marketing value available exclusively to level 3 members.

MC also hosts a podcast and a successful YouTube show that garnered over 313,800 views and 12,500 subscribers during 2023. This year a newly launched interview series featuring curated interviews with immigration service providers, industry experts, established institutions and more also brought over 11,500 views in 2023.

### EDUCATION PARTNER -PROGRAM-

Our EPP Program has been a valuable part of CAPIC over the years, benefiting not only CAPIC, but many international students as well. While EPP was made available for all members to use, unfortunately, only a very small percentage utilized the program.

#### Due to circumstances that are beyond the control of the association, CAPIC terminated the program effective February 19, 2024.

We deeply appreciate your support of and faith in CAPIC and the EPP program and thank everyone who was instrumental in making the program a success.

In 2023, we saw an increase at all levels:

The number of participating members for EPP as of today has increased year over year since the introduction of the program in 2018.

The commissions paid to the EPP members keep increasing year by year:

2022: \$116,892.15 2021: \$31,105.86 2020: \$10,159,72 2019: \$9,103.43

The amount of student profiles by the end of 2023 increased by 25% versus 2022.

### SURETY BOND






