

July 1, 2022, to June 30, 2023 – CPD events

Below are the CPD events that have taken place within the above noted CPD year. If you attended in person /or live webinar you **MUST** claim them in this CPD year (July 1, 2022, to June 30, 2023). If you have watched videos or choose to watch videos after having attended, you can claim them for **THIS** CPD year or claim over to the next CPD year July 1, 2023, to June 30, 2024, **as long as you WATCH the videos after July 1, 2023 and the CPD is still valid/active. Note only 6 hours can be carried over per year!**

Note: If you attend an event live in person or live webinar, the CPD is valid THAT DAY ONLY. You then claim at the end of the CPD year even if you attended the session months earlier. BUT you must claim those in person/live webinar events in the CPD year you attended. If you watch the video, you must watch it before the CPD expires and then claim according to the time you watched it.

Examples:

I attended July 7, 2022, online webinar. I did not watch the video. You must **CLAIM** it this CPD year – as the event was attended July 7, 2022, and the CPD year ends June 30, 2023, so you claim now.

I watched the Sept 8, 2022, video on December 1, 2022. You must claim those CPD Hours in this CPD year of July 1, 2022, to June 30, 2023.

I bought Summit Series Part 2 on May 15, 2023. I have not yet watched the video. I plan to watch it on holiday, July 15, 2023. You cannot claim this in **THIS** CPD year as you have not watched it yet. After watching it, you then can claim those CPD hours for **NEXT** CPD year July 1, 2023, to June 30, 2024.

You cannot double claim an event in two succeeding CPD years. You can carry over 6 CPD hours from one year to the next.

- ✓ This CPD year is July 1, 2022, to June 30 2023.
- ✓ Next CPD year is July 1, 2023, to June 30 2024.

May 27/22 - 8 CPD hours VIDEOS valid for one year until May 26, 2026 - **If watched videos after July 1, 2022, you can claim those hours for THIS CPD YEAR July 1/22 to June 30/23. If attended in person/live – those hours VALID ONLY FOR LAST CPD YEAR June 1/21 to July /22**

June 08/2023 – In person (9 hours) online (8.5 hours)- **If attending in person/online, you must claim these hours for THIS CPD year.**

June 09/2023 In person (9 hours) online (8.5 hours) **If attending in person/online, you must claims these hours for THIS CPD year**

June 10/23 2 pre-recorded on demand videos June 10, 2023 (2 hours) – **if watched PRIOR to June 30, you must claim in THIS CPD YEAR.**

If you choose to watch ALL the videos for NCIC 2023 after July 1, 2023, you can claim those hours for NEXT CPD year.

If you have completed 50 CPD hours in this CPD year, you can only carry over 6 to the next CPD year.
