

## **Submitting CPD hours:**

A reminder that you submit your CPD hours directly to the CICC portal <u>Login</u> (collegeic.ca). Log in, go to your dashboard, go to ongoing education, go to CPD learning log.

Scroll down, enter select activity. It will bring up a search bar. Enter the first 2 or 3 words of the title, and you'll see a list of events. Pick what is relevant and enter date watched or attended.

#### July 1, 2023, to June 30, 2024 - CPD Events

Below are the CPD events that have taken place within the above noted CPD year. If you attended in person /or live webinar you MUST claim them in this CPD year (July 1, 2023, to June 30, 2024). If you have watched videos or choose to watch videos after having attended, you can claim them for THIS CPD year or claim over to the next CPD year July 1, 2024, to June 30, 2025, as long as you WATCH the videos after July 1, 2024, and the CPD is still valid/active. Note only 6 hours can be carried over per year!

**Note:** If you attend an event live in person or live webinar, the CPD is valid THAT DAY ONLY. You then claim at the end of the CPD year even if you attended the session months earlier. BUT you must claim those in person/live webinar events in the CPD year you attended. If you watch the video, you must watch it before the CPD expires and then claim according to the time you watched it.

#### **Examples:**

I attended July 7, 2023, online webinar. I did not watch the video. You must CLAIM it this CPD year – as the event was attended July 7, 2023, and the CPD year ends June 30, 2024,



so you claim now.

I watched the Sept 8, 2023, video on December 1,2023. You must claim those CPD Hours in this CPD year of July 1, 2023, to June 30, 2024.

I bought The Lonely Canadian on May 15, 2024. I have not yet watched the video. I plan to watch it on holiday, July 15, 2024. You cannot claim this in THIS CPD year as you have not watched it yet. After watching it, you then can claim those CPD hours for NEXT CPD year July 1, 2024, to June 30, 2025.

You cannot double claim an event in two succeeding CPD years. You can carry over **6 CPD** hours from one year to the next.

- √ This CPD year is July 1, 2023, to June 30 2024.
- ✓ Next CPD year is July 1, 2024, to June 30 2025.

# **NCIC 2024**

## 2024, May 23

In person – 5 hours (you can only attend 1 session per hour!)

Video - 9 hours (watch sessions missed and you can combine in person with sessions watched by video)

## May 24, 2024

In person – 5.5 hours in person (you can only attend 1 session per hour!)

Video – 10.5 (watch sessions missed and you can combine sessions watched in person) You must claim "in person hours" this CPD by June 30, 2024. If you watch the video after



June 30, 2024, you can claim in the next CPD year. If watched prior to June 30 please claim in this CPD year.

# **NCIC 2023**

If you attended NCIC in person June 8 +9, 2023 you <u>cannot claim those CPD</u> hours now as you had to claim those in person for CPD last year – that is July 1, 2022, to June 30 2023.

If you watched the videos <u>after July 1, 2023, and prior to expiry on June 5, 2024, you can claim those hours – 9 hours per day.</u>
