

# Terms and Conditions of Use

(Last updated on December 08, 2021)

Welcome to the IMMeForum. The IMMeForum is provided and administered by the Canadian Association of Professional Immigration Consultants ("CAPIC") for the professional benefit of its members. It is a place for members of CAPIC to communicate regarding issues of interest, report information, ask questions, share ideas, and discuss practice and procedural issues in relation to immigration and citizenship consulting.

By accessing, browsing, or using the IMMeForum, you agree to be bound by these terms and conditions ("**Terms of Use**"), CAPIC's *Code of Conduct and Ethics*, CAPIC's *By-Laws*, and all applicable laws and regulations. **IF YOU DO NOT AGREE WITH ANY PART OF THESE TERMS OF USE, YOU MUST IMMEDIATELY DISCONTINUE USE OF THE IMMefORUM.**

CAPIC may, in its sole discretion, modify and revise these Terms of Use and CAPIC's *Code of Conduct and Ethics* from time to time without notice to you and you agree to be bound by such modification. ## Rules:

Individuals accessing the IMMeForum ("**Forum Users**") must use their first and last name with all their messages. You are responsible for any use of the IMMeForum, and messages posted using your login details. You shall not share your login details with anyone.

Forum Users shall not post on the IMMeForum any content which:

1. violates CAPIC's *Code of Conduct and Ethics*;
2. is not consistent with the professional objectives of the IMMeForum;
3. is abusive, offensive, harmful, obscene, harassing, hateful, racist, threatening, injurious to any person, group or entity, or is otherwise inconsistent with the proper kind of professional communications expected from a member of CAPIC;
4. contains swearwords, bad language, or offensive nicknames;
5. may be defamatory of any person, group, or entity;
6. is not courteous and civil towards other member(s), client(s) of immigration consulting services, government officials, or members of the public;
7. may be harmful to the reputation of CAPIC;
8. impersonates a person, assumes a false identity, falsely states or otherwise misrepresents one's affiliation with a person, entity, or group, or disguises the origin of any content of a message;
9. constitutes a taunt published to ridicule another person, entity or group, or an IMMeForum topic. Persistent off-topic comments, posting or statements are prohibited;
10. contains materials which encourages conduct that would constitute a criminal offense, which violate the rights of others, or that would otherwise violate any applicable local, provincial, national or international law;
11. in any way breaches the confidence of another individual. In particular:
  - a. All Forum Users must remove a client's personal information when publishing on the IMMeForum and must not publish any characteristics which may reveal a client's identity;

- b. Forum Users must not post any messages containing any individual's personal information (including their name, address, job title, cell phone number or other contact details) without first obtaining that person's written consent;
12. contains material (including but not limited to photographs, programs, publications, trade secrets, copying and pasting text of news stories) protected by privacy, copyright, trademark or any other applicable laws, unless you own or control the rights thereto or have obtained all necessary consents to upload the material on the IMMeForum. By posting messages that contain such materials, the Forum User warrants that he or she owns the right to such materials or has received permission from the owner. In addition, the posting Forum User grants CAPIC and the users of the IMMeForum the non-exclusive right to display, copy, publish, distribute, transmit, print and use such protected material. Alternatively, it is acceptable to provide a hyperlink to the protected materials, or alternatively quote the material with the full citation;
13. is published for a commercial purpose, contains or links to advertising, including advertising of a service or educational program not being offered by the Corporation, is published for the solicitation of funds, or is published for the solicitation of goods and services, unless prior written authorization is provided by CAPIC;
14. contains destructive features such as: viruses; computer code or programs designed to interrupt, destroy or limit the functionality of any computer software, hardware, and telecommunications equipment; Trojan horses; or Bots (Bots are programs that operate as agents, such as spiders or crawlers, that access web sites and gather their content for search engine indexes); or,
15. encourages or facilitates members to arrive at any agreement or understanding that, if carried into effect, would be likely to lessen competition among or between members in any market of immigration consulting or immigration legal services. Such communications may be contrary to competition laws.

Forum Users are advised to use caution when discussing or using the IMMeForum to comment upon the products or services offered by others. Your publications are subject to defamation and competition laws.

Forum Users may participate in either official language, French or English. However, translation is not provided by CAPIC.

Forum Users that are student members of CAPIC may read the posts on the IMMeForum but may not post content on the IMMeForum.

### **Remedies**

CAPIC reserves the right, at its sole discretion and without notice, to remove or edit any messages, including, without limitation, any post that CAPIC considers at its sole discretion to be harmful, and/or to suspend or exclude the Forum User that posted such content from the IMMeForum (either temporarily or permanently).

Without prejudice to CAPIC's other rights, if you breach these Terms of Use, CAPIC's *Code of Conduct and Ethics*, or CAPIC's *By-Laws*, CAPIC may take such action as CAPIC deems appropriate to deal with the breach, including suspending your access to the IMMeForum and other social media sites, prohibiting you from accessing these services, blocking computers from using your IP address and from accessing these services, and contacting your internet service provider to request that they block your access to the IMMeForum. CAPIC is also at

liberty to take the steps and impose remedies set out in the CAPIC's *Code of Conduct and Ethics*, CAPIC's *By-laws*, CAPIC's Discipline Policy and Procedure, and any other CAPIC policy in affect from time to time, including but not limited to suspending or terminating one's membership in CAPIC.
